## Payment Terms

- A deposit of \$550 is required to secure your initial consultation to discuss which assessment is most appropriate for the client.
- Once the assessment sessions are scheduled the full quoted fee is due 5 business days prior to the scheduled appointment.
- If payment is not received by this time, the appointment may be postponed or cancelled.
- For assessments funded by third parties, please discuss payment terms at the time of booking.

## Cancellation Policy

- We kindly request a minimum of 5 business days' notice for cancellations or rescheduling.
- If cancellation occurs within 5 business days of the scheduled appointment, the \$550 deposit will be forfeited.
- If cancellation occurs within 2 business days of the assessment appointment, 50% of the full assessment fee will be forfeited, as it is unlikely the appointment can be filled at short notice.
- This policy enables us to offer the appointment to another client or recover costs related to the psychologist's time preparing for your assessment.

# Assessment Process

Our comprehensive assessments may include:

- Clinical interview with parents/carers and/or the client (age specific) to determine what assessment type is the most appropriate for the client.
- You receive a quote for the fees payable for the proposed assessment type.
- Standardised testing tailored to the individual's needs.
- Observations and questionnaires to assess various aspects of functioning.
- School visit where applicable.
- Other interviews as needed.
- Feedback session to discuss results, recommendations, and answer any questions that might arise.
- A detailed written report provided within 4 weeks from completed assessment.

## Frequently Asked Questions

What is included in the assessment process, and how long does it take?

Our comprehensive assessments typically involve:

- Initial Consultation: clinical interview to determine assessments
- Standardised testing sessions
- Behavioural questionnaires (as appropriate)
- Teacher questionnaire (where appropriate)
- A feedback session to discuss results
- A detailed written report with findings and recommendations

The length of the full process depends on the assessment package and the age of the participant.

Will I receive a formal diagnosis and a report that can be used for school, work, or NDIS?

Yes. If the assessment results meet diagnostic criteria, your report will include a formal diagnosis and specific recommendations. Our reports are suitable for school or workplace accommodations, NDIS applications, and other support services.

Can I claim any of the assessment fees through Medicare or private health insurance?

Most assessment services are not covered by Medicare unless part of a specific plan (e.g., Helping Children with Autism or a Chronic Disease Management Plan). However, some private health funds may provide a rebate—please check directly with your provider.

How do I know whether I need an ADHD, ASD, or general cognitive assessment?

If you're unsure, we recommend starting with an initial consultation. In this session, the psychologist will explore your concerns and guide you towards the most suitable assessment for your needs.

Why do you include a cognitive assessment with an ADHD and ASD assessments?

A cognitive assessment helps clarify whether challenges like inattention or social difficulties are due to ADHD, autism, or other learning or developmental differences. It provides objective data that supports accurate diagnosis and helps distinguish between conditions. The results also guide practical supports by showing how the individual learns best and what strategies may help them thrive.
